#### Meeting held via Zoom

# 4. Public Hearing on the Continuity of Learning Plan 4.0

Ms. Carolyn Meza, ACPS parent, encouraged more frequent communication between teachers and parents during virtual learning, and asked that ACPS consider learning pods when making class assignments.

Mr. Jeremy Flachs, ACPS parent, commented that ACPS made the right decision by choosing a virtual model for the fall. He also hoped for a smooth experience that includes more structure, oversight, and feedback. Mr. Flachs asked ACPS to make plans for those who do not have the option to stay home with their children.

Mr. Kyle Martin, ACPS parent, indicated that he and his wife are full-time, essential, in-person workers and asked the School Board to address how families such as his can make the 100% virtual model work for them. He also asked that ACPS provide detailed information about the child care options mentioned in the Virtual Plus plan.
