Meeting Held via Zoom

Call to Order

1. Meeting Called to Order by Chair Anderson

Chair Anderson called the meeting to order at 8:02 a.m. Members of the School Board present at the start of the meeting were Chair Anderson, Vice Chair Nolan, Ms. Gentry, Ms. Greene, Ms. Lorber, and Dr. Rief. Mr. Suarez joined after the vote to amend the agenda. Ms. Alderton and Ms. Thornton joined during the Closed Meeting.

Adoption of Meeting Agenda

2. Adopt the Meeting Agenda for the October 22, 2020 virtual Special Called School Board Meeting

Ms. Gentry moved to amend the agenda to add the item "Motion to Approve Settlement" after the Certification of the Closed Meeting.

Ms. Greene seconded the motion

The vote to amend the agenda to add "Motion to Approve Settlement" was unanimous, 6-0. The motion carried. The vote was taken by roll call.

The vote to adopt the meeting agenda was unanimous, 7-0. The motion carried. Mr. Suarez had joined the meeting just prior to the vote. The vote was taken by roll call.

Closed Meeting and Certification of Closed Meeting

3. Closed Meeting

Vice Chair Nolan moved that the Board convene a Closed Meeting pursuant to Virginia Code 2.2-3711(A)(7) for consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the Board.

5. Motion to Approve Settlement

City of Alexandria and Alexandria City School Board; Cacheris v. City of Alexandria and Alexandria City School Board; and Goff et al. v. City of Alexandria and Alexandria City School Board, on the terms discussed in closed session; and authorize the School Board Attorney to execute on behalf of the School Board a Consent Order in a form consistent with that reviewed in closed session, contingent on approval of the settlement by all parties to the above litigation.

Mr. Suarez seconded the motion. The vote was unanimous, 8-0, to approve the settlement as discussed in the Closed Meeting and authorize the School Board Attorney to issue a Consent Order on behalf of the School Board. The motion carried. The vote was taken by roll call. Board Member Lorber did not return after the Closed Meeting.
