Due to shortages, we are currently receiving about 2000 vaccinations per week (2 nd dose allocations are not included in this number, they are guaranteed for people who have already received the first dose). Working with the K-12 and daycare providers to provide vaccinations and anticipate to have a majority of them vaccinated by the end of next week.
