### Call to Order

### 1. Meeting Called to Order by Chair Alderton

## 1. Adopt the Meeting Agenda for the May 27, 2021 Virtual Special Called School Board Meeting

Ms. Lorber moved to adopt the meeting agenda for the May 27, 2021 Virtual Special Called School Board Meeting.

Mr. Suarez seconded the motion.

Lastly, Ms. Greene moved that the Board convene a Closed Meeting pursuant to Virginia Code 2.2-3711(A)(8) for consultation with legal counsel employed or retained by a public body regarding specific legal matters requiring the provision of legal advice by such counsel.

Mr. Suarez seconded the motion. The vote was unanimous, 8-0, to convene a Closed Meeting. The motion carried. A roll call vote was taken.

The Board moved into a Closed Meeting at 6:39 p.m.
