1. Meeting Called to Order by Chair Alderton

Adoption of Meeting Agenda

3. Adopt the Meeting Agenda for the April 8, 2022 Special Called School Board Meeting

Dr. Rief moved to adopt the meeting agenda for the April 8, 2022 Special Called School Board Meeting.

Ms. Ignacio seconded the motion.

The vote to adopt the meeting agenda for April 8, 2022 was unanimous, 5-0. A roll call vote was taken. The motion carried.

4. Allow Participation of Board Member Jacinta Greene by Electronic Means

Dr. Rief made the following motion:

"Whereas Board member Jacinta Greene has notified the Board that she is unavailable to be physically present for today's Special Called School Board Meeting due to a business matter specifically, needing to be present at a work location, and whereas she has not participated in more than two or 25% of School Board Meetings by electronic means during 2022; and whereas Board Member Jacinta Greene requests the opportunity to participate in the Special Called School Board Meeting by video conference call from Arlington, Virginia, where the

video conference call shall be heard by all participants in the Board room; and whereas a quorum of the School Board is physically assembled in this Board room;

Therefore, I move, pursuant to Virginia Code 2.2-3708 that the Board approve the participation of Board Member Jacinta Greene is this meeting by video conference call."

Ms. Ignacio seconded the motion.

The vote to allow Board Member Jacinta Greene to join the Special Called School Board Meeting by electronic means was unanimous, 5-0. The motion carried.

Vice Chair Greene joined the meeting via Zoom.

Closed Meeting and Certification of Closed Meeting

5. Closed Meeting
