11. Notification of Closed Meeting for the Purpose of Interim Superintendent Interviews

Vice Chair Greene moved that pursuant to VA Code 2.2-3712 (b) that the Board hereby notifies the public that closed meetings will be held in the next 15 days at undisclosed locations for the purpose of interviewing candidates for Interim Superintendent.

Mr. Elnoubi seconded the motion.

The vote to approve the notification to the public of the closed session to be held within 15 calendar days, was unanimous, 9-0. The motion carried. Ms. Ignacio voted orally in the affirmative.

Old Business & Action Items

9. Simpson Field

The Simpson Field site is currently used by the City of Alexandria's Recreation Parks and Cultural Activities (RPCA) as soccer and baseball fields. As part of CDD2007-0001 and Concept Plan Amendment for Potomac Yard/Potomac Greens, a portion of this site was designated for ACPS use, if jointly agreed with the City, to be developed into a school. Given that APCS has not scheduled a new school at this site in the current 10-year CIP Budget, ACPS staff can negotiate the use of the fields by RPCA. Dr. Alicia Hart, Chief of Facilities and Operations, indicated that there was no new information on this agenda item, regarding the use of Simpson Field by the City but her team was here to answer questions.

Board Members asked questions regarding clarity of the size of the site that was being discussed, what terms will be discussed in the negotiations with City staff, the availability of additional acreage if needed for a school site and where the final agreement language will be available for future reference.

Ms. Erika Gulick, Director of Capital Programs, Planning and Design, clarified the size of the area being discussed. She indicated that the soccer field is approximately four acres of land and the baseball field approximately two acres. Ms. Sophie Huemer, Planner II, further clarified that the space is approximately 120,000 sq. ft. of land.

Mr. Elnoubi moved to allow the City of Alexandria use of the identified site at Simpson Fields for a minimum of ten years and permit staff to negotiate the final details of field use by RPCA.

Ms. Booz seconded the motion.

The vote to allow use of Simpson Field for a minimum of 10 years by RPCA was unanimous, 9-0. The motion carried. Ms. Ignacio voted orally in the affirmative.

Superintendent Hutchings reported on visiting Alexandria City High School where summer school is underway and operating smoothly.
