CLOSED MEETINGS

 A. Closed meetings may be held by the School Board or any committee thereof only in accordance with Virginia law, for purposes including the following:

- 1. Discussion, consideration or interviews of prospective candidates for employment, assignment, appointment, promotion, performance, demotion, salaries, disciplining or resignation of specific public officers, appointees or employees of the School Board. Any teacher shall be permitted to be present during closed meetings in which there is a discussion or consideration of a disciplinary matter which involves the teacher and some student and the student involved in the matter is present, provided the teacher makes a written request to be present to the presiding officer of the School Board. The School Board may not, however, discuss the compensation of Board members in closed session.
- 2. Discussion or consideration of admission or disciplinary matters or any other matters that would involve the disclosure of information contained in a scholastic record concerning any student in the Alexandria City school division. However, any such student, legal counsel and, if the student is a minor, the student's parents or legal guardians shall be permitted to be present during the taking of testimony or presentation of evidence at a closed meeting, if such student, parents or guardians so request in writing and such request is submitted to the presiding officer of the School Board.
 - 3. Discussion or consideration of the acquisition of real property for public purpose, or of the disposition of publicly held real property where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the School Board.
 - 4. The protection of the privacy of individuals in personal matters not related to public business.
 - 5. Discussion concerning a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business' or industry's interest in locating or expanding its facilities in the community.
 - 6. Discussion or consideration of the investment of public funds where competition or bargaining is involved, where if made public initially, the financial interest of the School Board would be adversely affected.
- Consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the School Board. For purposes of this subsection, "probable litigation" means litigation which has been specifically threatened or on which the School Board or its legal counsel has a reasonable basis to believe will be commenced by or against a ALEXANDRIA CITY PUBLIC SCHOOLS

47 48	known party. The closure of a meeting is not permitted merely because an attorney representing the School Board is in attendance or is consulted on a
49	matter.
50	8. Consultation with legal counsel employed or retained by the School Board
51	regarding specific legal matters requiring the provision of legal advice by such
52	counsel. The closure of a meeting is not permitted merely because an attorney
53	representing the School Board is in attendance or is consulted on a matter.

55	9. Discussion or consideration of honorary degrees or special awards.
56	
57	10. Discussion or consideration of tests or examinations or other information used,
58	administered or prepared by a public body and subject to the exclusion in
59	subdivision 4 of Va. Code § 2.2-3705.1.
60	
61	11. Discussion of strategy with respect to the negotiation of a hazardous waste siting
62	agreement or to consider the terms, conditions, and provisions of a hazardous
63	waste siting agreement if the School Board in open meeting finds that an open
64	meeting will have an adverse effect upon the negotiating position of the School
65	Board or the establishment of the terms, conditions and provisions of the siting
66	agreement, or both. All discussions with the applicant or its representatives may
67	be conducted in a closed meeting.

69	12. Discussion or consideration of medical and mental health records subject to the
70	exclusion in subdivision 1 of Va. Code § 2.2-3705.5.
71	
72	13. Discussion of plans to protect public safety as it relates to terrorist activity or
73	specific cybersecurity threats or vulnerabilities and briefings by staff members,
74	legal counsel, or law-enforcement or emergency service officials concerning
75	actions taken to respond to such matters or a related threat to public safety;
76	discussion of information subject to the exclusion in subdivision 3 or 4 of Va.
77	Code § 2.2-3705.2 where discussion in an open meeting would jeopardize the
78	safety of any person or the security of any facility, building, structure, information
79	technology system or software program; or discussion of reports or plans related
80	to the security of any government facility, building or structure, or the safety of
81	persons using such facility, building or structure.
82	
83	14. Discussion or consideration of information subject to the exclusion in subdivision
84	11 of Va. Code § 2.2-3705.6 (the Public Private Education Facilities and
85	Infrastructure Act) by the School Board or any independent review panel
86	appointed to review the information and advise the School Board concerning such
87	information.
88	
89	15. Discussion of the award of a public contract involving the expenditure of public
90	funds, including interviews of bidders or offerors, and discussion of the terms or
91	scope of such contract, where discussion in an open session would adversely

- 92 affect the bargaining position or negotiating strategy of the School Board.
- B. No resolution, ordinance, rule, contract, regulation or motion adopted, passed or agreed
 to in a closed meeting shall become effective unless the School Board, following the
 meeting, reconvenes in open meeting and takes a vote of the membership on such
 resolution, ordinance, rule, contract, regulation or motion which shall have its substance
 reasonably identified in the open meeting.
- C. The School Board or any committee thereof may permit nonmembers to attend a closed
 meeting of the Board or committee if such persons are deemed necessary or if their
 presence will reasonably aid the Board or committee in its consideration of a topic which
 is a subject of the meeting. The attendance of these individuals does not alter the status of
 such meeting as a closed meeting for purposes of FOIA.
- D. School Board members may attend closed meetings held by any committee or 106 subcommittee of the Board, or a closed meeting of any entity, however designated, 107 created to perform the delegated functions of or to advise the Board. School Board 108 members shall in all cases be permitted to observe the closed meeting of the committee, 109 subcommittee or entity. In addition to the requirements of Va. Code § 2.2-3707, the 110 minutes of the committee or other entity shall include the identity of the School Board 111 members who attended the closed meeting. The attendance of these individuals does not 112 alter the status of such meeting as a closed meeting for purposes of FOIA. 113
