Policies and Regulations

- Policy is a <u>basic statement of the intent</u> of the School Board which creates rights and responsibilities for the conduct of the school division's business. Policies are adopted by the Board.
- Regulation is the manner or <u>method of implementation</u> of policy by the Superintendent and staff, subject to change as conditions and/or circumstances may dictate. Regulations are approved by the Superintendent.

Standard Changes

Standard Changes used on all policies and regulations

- Remove gender affirming terms
- Replace parent with parent/guardian
- · Reduce the use of 'shall' per VSBA model policy changes
- Add breadcrumbs to other policies
- Reword and reformat to improve readability
- Relocate definitions to the beginning

Draft Revisions

EFB/JHCH - ACPS School Nutrition Services EFB/JHCH-R Regulations for School Meals and Snacks

- Shifted responsibility from schools to SNS to inform parents in writing if they have more than \$30 in unpaid meal charges.
- Regulation updated to strengthen language that non-food items should be used to reward student behaviors.
- Policy updated to reflect a six-day deadline for processing free and reduced breakfast and lunch applications per the amendment of Va. Code § 22.1-207.2:2 by HB 587 from 2022, which had a delayed effective date until 8/1/23.

GBEF - Lactation Support (also JHCL)
