SUMMARY:

The division, in collaboration with Hanover Research, has developed a data digest to provide key data across various areas within the organization that include both pre- and post-pandemic indicators all within a single accessible resource. This data digest displays trend data for Key Performance Indicators (KPIs) within the current strategic plan as well as other strategic division data and will be updated annually. Further, the digest will be used and updated as a foundational document informing the upcoming strategic planning process.

BOARD BRIEF

DETAILS:

The attached digest was designed to provide a synopsis of available data summarizing where ACPS has been since the start of the strategic plan. These data serve to provide a common understanding of and trend data for key indicators spanning the system. The digest is organized around five chapters:

- Enrollment and demographics
- Key Performance Indicators
- Academic achievement
- Behavior and social-emotional learning
- Stakeholder perceptions, and
- Staffing and operations

Each chapter highlights multiple indicators and trends observed within the data over time and across groups. Summaries of recent program evaluations, audits, and plans are also included within the digest. The digest is designed to be a high level overview and; therefore, may not be exhaustive of all possible data points of interest. Should additional background be desired, sources for all data are referenced at the back of each chapter.

BACKGROUND:

ACPS first began consolidating data across various indicators in a workbook format in 2019 to facilitate discussion with the division's strategic planning committee around evidence of successes and opportunities to address equity within the division. It has been updated with data from 2019-2023 and will be used and updated as a foundational document informing the next strategic planning process.

RECOMMENDATION:

The Superintendent recommends the School Board review the attached materials for possible planning, procedural, programmatic, and/or budgetary changes.

IMPACT:

This data digest provides data that serve to illuminate persistent inequities, develop shared understanding of the strategic levers that can impact change, and monitor progress for disrupting predictable patterns of inequities and the practices that perpetuate them.
