Current Projects Promoting Universal Design

Facilities staff have also been involved in several projects promoting universal design throughout the School Division.

- Elevator projects at Francis C. Hammond Middle School, George Washington Middle School and William Ramsay Elementary School to promote accessibility to all students, staff and visitors of our schools.
- The Special Education Department has been involved in the design review process for new facilities projects including the new Patrick Henry School and Recreation Center and New West End Elementary School. These projects will provide accessible and unobstructed paths of travel to all areas of the building for all users of the facility.¹ Ramps in the building with gentle slopes, conducive to wheelchair users, accessible bathrooms and building amenities for those with hearing and/or sight impairments are a few of the design criteria being included for the new school.
