

MOU SRO Quarterly Performance Report February 2024

Overview

Quarterly meetings between Alexandria City Public Schools (ACPS) and the Alexandria Police Department (APD) are required as part of the SLEP Memorandum of Understanding (June 2023). Meetings are scheduled to occur August, November, February and May. The most recent meeting occurred on Tuesday, February 20, 2024. This report period includes November and December 2023, and January 2024. The next meeting will occur May 2024.

After each quarterly meeting, a subsequent report is to be completed and shared to provide updates on:

- **Section I: VDOE Annual Discipline, Crime and Violence Report.** As noted in the June 2021 SRO Quarterly Update, the annual VDOE Discipline, Crime and Violence report has been replaced by the VDOE Student Behavior Administrative Response (SBAR) report. SBAR incidents are recorded through the end of the school year. Public availability to annual reports is made by VDOE. If there are any questions on this item, please contact the Department of Student Services and Equity.
- **Section II: Police Statistical Reports.** This information is in relation to the Calls for Service form; more details on this item noted later in this document.
- **Section III: VDOE School Climate Survey.** This information is in relation to the required Code of Virginia School Safety Survey that is completed annually.
- **Section IV: School Resource Officer (SRO) Performance Items.** This information includes SRO attendance and incident reporting.
- **Section V: Educational Activities with Students:** This information includes any educational offerings by SRO's for students.

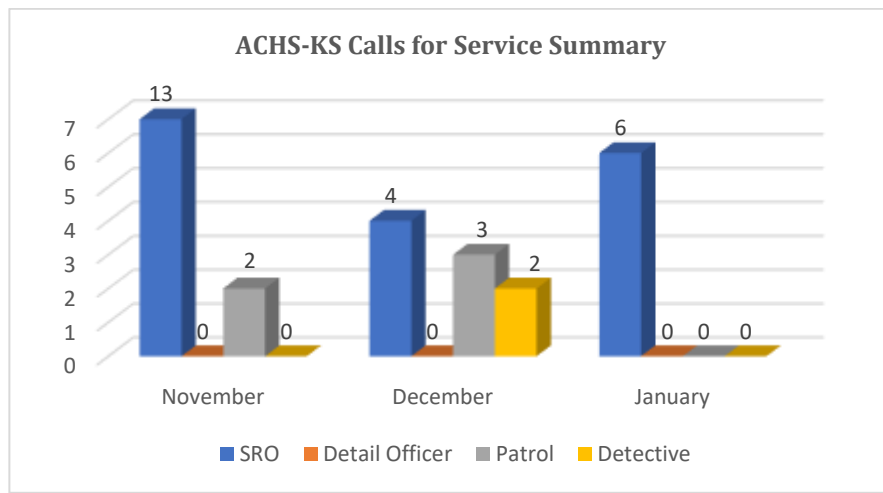

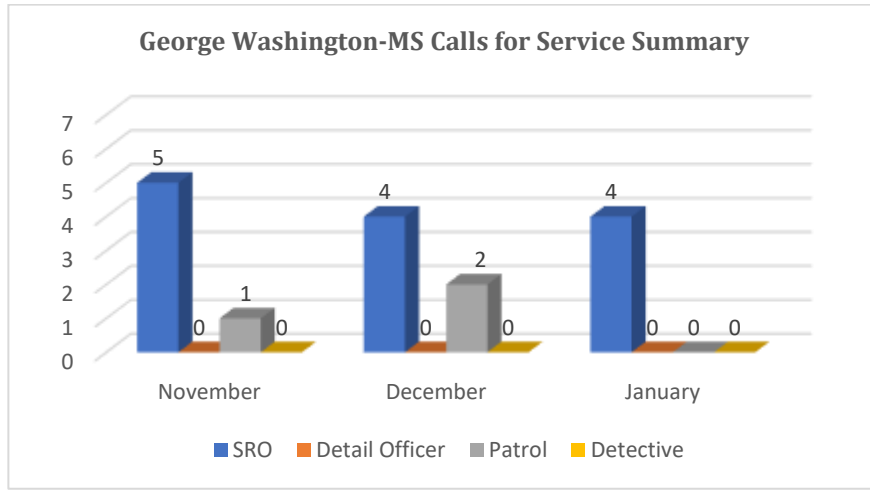

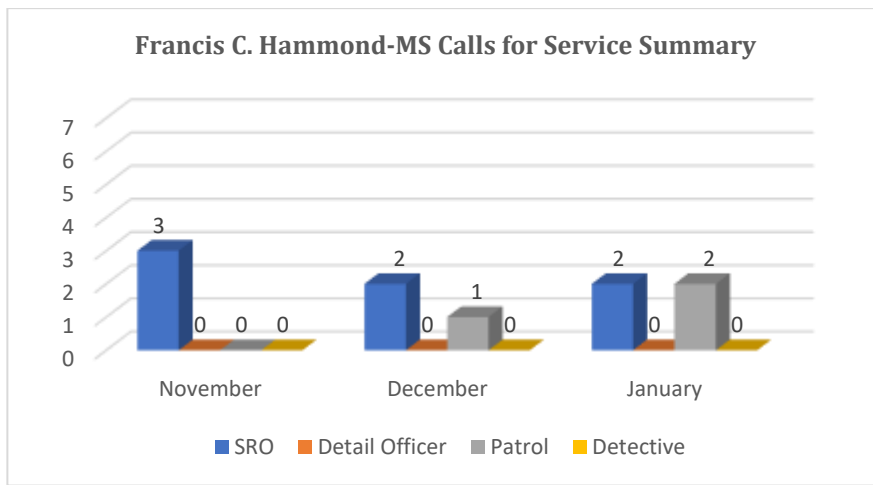

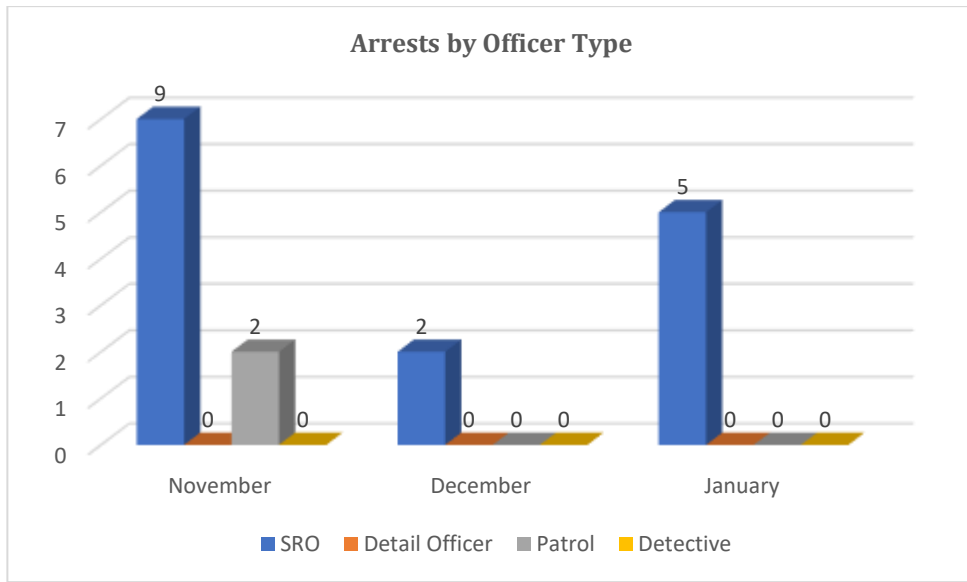

Arrests/Referrals by Officer Type

There was a total of 18 arrests/referrals made during this quarterly reporting period for school year 2023-24. The below chart breaks out arrests/referrals by month and officer type:

Note: The term “Referral” has been added to the arrest data lexicon. This change in lexicon is due to APD’s alignment with the Department of Criminal Justice Services (DCJS) letter dated March 20, 2023. This letter describes the categories used in legislation aimed at collecting data on School Resource Officers and their actions with students (Use of Force, Physical Restraint, Detention, Arrest, and Referrals to Court Services).

- November: 11 Arrests/Referrals (SRO – 9, Patrol – 2)
- December: 2 Arrests/Referrals (SRO – 2)
- January: 5 Arrests/Referrals (SRO – 5)



Section III: VDOE School Climate Survey

Currently, there is a survey in progress. This survey, being administered to grades 9 through 12, will run from January 15, 2024 through March 1, 2024. This annual survey is a component of the school safety audit, which school divisions are required to submit to the Virginia Center for School and Campus Safety, according to § 22.1-279.8.B of the Code of Virginia. This survey, conducted jointly by the Virginia Department of Education (VDOE) and the Virginia Department of Criminal Justice Services (DCJS) will be available on the

The latest Virginia School Survey of Climate and Working Conditions was completed February 24, 2023 and is available on the Safety & Security Services website. Staff and students for grades 6 through 8 were surveyed during the open period of January 9, 2023 to February 24, 2023.
