

- The total budget including carryover for all projects is \$69.9 million. This includes the Patrick Henry Pre-K 8 at \$42.1 million.
- \$9.8 million of expenditures have been incurred through June 2016 with an additional \$4.2 million committed to support various projects.
- After staff review of completed projects and other accounts, approximately \$96,000 is currently available for reprioritization in accordance with established policy.
