#### Call to Order

sense of community in a safe environment, improved grades and empowered them to attend college and find their path for the future.

The Alexandria City School Board viewed the newly produced video, "Welcome to ACPS", the second in a series to support ACPS' 2023 recruitment campaign "Join Our Equity Journey: Live. Impact. Grow." This brief video leads a digital journey through the City of Alexandria to provide a glimpse of the activities and attractions that can be enjoyed in Alexandria, including historic sites, natural beauty, restaurants and art installations.

# 7. Wear Orange Weekend-Gun Safety Awareness

Each year, the Alexandria City School Board reminds the public of its support of National Gun Violence Awareness Day, the first Friday in June, and Wear Orange Weekend, celebrated the first weekend in June. Orange has been the defining color of the gun violence prevention movement. In June 2022, the School Board updated its Resolution Against Gun Violence to support measures to reduce the number of guns and eliminate gun violence in our communities. The vote to adopt the Consent Calendar was unanimous, 8-0. The motion carried.

#### **Closed Meeting and Certification of Closed Meeting**

#### 22. Closed Meeting

Vice Chair Greene moved that the Board convene a Closed Meeting pursuant to Virginia Code 2.2-3711(A)(1) for the discussion and consideration of employment, performance, and

contractual matters for 2500 specific public employees. She further moved that the Board convene a Closed Meeting pursuant to Virginia Code 2.2-3711(A)(6) for discussion or consideration of the investment of public funds where competition or bargaining is involved and, where, if made public, would adversely affect the financial interest of the Board.

Dr. Rief seconded the motion. The vote was unanimous, 8-0, to convene a Closed Meeting. The motion carried.

The Board moved into a Closed Meeting at 7:55 p.m.

#### 23. Certification of Closed Meeting

Vice Chair Greene moved that pursuant to Virginia Code 2.2-3712, that the Board certifies that to the best of each member's knowledge, only public business matters identified in the motion by which the Closed Meeting was convened, and which are lawfully exempted by the Freedom of Information Act, were heard, discussed or considered by the Board in the Closed Meeting held on June 1, 2023.

Dr. Rief seconded the motion.

The vote was unanimous, 7-0, to certify the Closed Meeting. The motion carried. Mr. Harris was not present for the vote.

The Board returned to open session at 9:50 p.m.

#### **Old Business & Action Items**

# 24. Alexandria City Public Schools/Alexandria Police Department Memorandum of Understanding (MOU)

Dr. Alicia Hart, Chief of Facilities and Operations, provided an updated final draft of the ACPS/APD MOU that requires review and approval every two years. The proposed updates were made from the signed October 2020 version of the MOU and feedback by the School Board and City Council Members was included. In order to maintain adherence to MOU review and approval requirement, the updated MOU must be signed no later than June 30, 2023.

Ms. Booz moved to adopt the ACPS/APD MOU.

Dr. Simpson Baird seconded the motion.

The vote to adopt the ACPS/APD MOU was unanimous, 6-0. The motion carried. Mr. Elnoubi and Mr. Harris were absent from the vote.

# 25. Adoption of the FY 2024 Combined Funds Budget

As ACPS moves forward in its efforts to realize the mission and vision established in ACPS 2025 strategic plan, to prepare every student to have the skills necessary to be successful in the 21st century through equitable access to opportunities, achieving academic excellence, where every school is high performing and every student succeeds, the adoption of the Combined-Funds Budget is an annual commitment to meeting these goals.

Vice Chair Greene made the following motion:

"Madam Chair, I move that the Alexandria City School Board approve the FY 2024 Combined Funds Budget as follows:

• The FY 2024 Operating budget in the amount of \$333,442,978 for both revenues and expenditures. This includes other financing sources and uses, as well as a planned use of general fund balance in the amount of \$8,722,578, including a transfer out to the Capital Improvement Program of \$1,966,021, along with a \$1,200,000 transfer in from the Capital Improvement Program, and a transfer out of \$2,030,546 to the Grants and Special Projects Fund. The Operating budget includes 2,442.00 FTEs and

a total City appropriation of \$258,686,800. The \$1,966,021 transfer to the CIP shall be contingent upon the following actions from the City of Alexandria:

- The summer youth employment program grows to a minimum of 200 participants
- A partnership with ACPS is established to provide a minimum of 150 students with employment
- Explore increasing the salary for the program from \$12/hour to at least
   \$15/hour to ensure the Alexandria livable wage is met
- The FY 2024 Grants and Special Projects budget in the amount of \$17,850,779 for revenues and expenditures. This also includes a transfer of \$2,030,546 from the Operating Fund to provide supplemental funding support to the Virginia Preschool Initiative (VPI) program. This budget includes a total of 111.45 FTEs.
- The FY 2024 School Nutrition Services budget totals \$12,600,871 for revenues and \$12,600,871 for expenditures. This budget includes a total of 121.00 FTEs.

The Superintendent is granted the authority to make the necessary minor changes to comply with the intent of the School Board. Additionally, the School Board authorizes the encumbrances remaining as of June 30, 2023 to carry forward from FY 2023 to FY 2024 as an adjustment to the final budget."

Dr. Rief seconded the motion.

The vote to approve the FY 2024 Combined Funds Budget was unanimous, 8-0. The motion carried.

# 26. Adoption of the FY 2024-2033 Capital Improvement Program (CIP) Budget

Based on the City of Alexandria's Approved Budget, there were a few adjustments to the CIP, which resulted in a \$7.5 million reduction from the School Board's approved FY 2024 CIP Budget. The total adjusted FY 2024 CIP budget is now \$51,255,900, which matches the City Council Approved CIP Budget. Below are the adjustments which were incorporated into the FY 2024-2033 CIP:

- Defer leased space renovation for the Chance for Change facility from FY 2024, \$2M, to FY 2025 and from FY 2025, \$10M, to FY 2026 Reduce Patrick Henry completion from \$3.4M to \$2.9M based on bids received for this work
- Reduce FY 2024 funds for renovation of the 5th and 6th floors at Ferdinand T. Day from \$5.5M to \$0.5M to allow for re-initiation of design to start and move remaining funds with escalation to FY 2025, \$5.2M
- Re-allocate the \$2.0M proposed for William Ramsay HVAC to System-Wide HVAC to
  account for potential changes in ESSER funding and enable efficiency of the Educational
  Facilities team to get all proposed and in progress HVAC renovation projects completed
- Increase System-Wide Emergency Repairs account by \$0.05M

Vice Chair Greene made the following motion:

"Madam Chair, I move that the Alexandria City School Board adopt the FY 2024–2033 Capital Improvement Program Budget in the total amount of \$460,763,500, with \$51,255,900 in FY 2024.

The Superintendent is granted the authority to make the necessary minor changes to comply with the intent of the School Board."

Dr. Rief seconded the motion.

The vote to adopt the FY 2024-2033 CIP Budget was unanimous, 8-0. The motion carried.

# 27. ESSER III Fund Plan Update

Mr. Dominic Turner, Chief Financial Officer, presented information on the use of ESSER III funding. The purpose of the American Rescue Plan (ARP) Act Elementary and Secondary School Emergency Relief (ESSER) III Fund is to help safely reopen and sustain the safe operation of schools and address the impacts of COVID-19 on the nation's students by addressing students' academic, social, emotional, and mental health needs. ACPS was awarded \$34.8 million in ESSER III funds which was used to align with the following four Focus Areas: (1) Social, Emotional and Academic Learning, (2) Technology Infrastructure, (3) COVID-19 Prevention and Mitigation Projects, and (4) Human Capital Needs.

# New Business and Reports to the Board

# 28. Boundary Analysis

As a follow-up to the boundary analysis proposed during the February 16, 2023 School Board meeting, staff presented an updated boundary analysis to the School Board for consideration. Ms. Erika Gulick, Executive Director of Facilities, and Ms. Sophie Huemer, Principal Planner, reviewed why ACPS is conducting a boundary analysis, current live-in and enrolled demographics of ACPS schools, development that will further impact the demographics of our school boundaries, and key findings. The School Board is being asked to review this information to determine if a redistricting effort would be needed.

# 29. Special Education Update

Ms. Theresa Werner, Executive Director of Specialized Instruction, presented information on disproportional practices in the identification of students for special education services. Comprehensive Coordinating Early Intervening Services (CCEIS) are services provided to students in kindergarten through grade 12 who are not currently identified as needing special education or related services, but who need additional academic and behavioral supports to succeed in a general education environment. These activities and services are designed to prevent referrals for special education services and address the disproportional identification of students as disabled.

#### 30. Joint City Council/School Board SLEP Subcommittee

Dr. Alicia Hart, reported on the School Law Enforcement Partnership (SLEP) Advisory Group recommendations which were shared at the February 27, 2023 Joint City Council/School Board Work Session. As part of the discussion, a recommendation was made to form a Joint City Council/School Board SLEP Subcommittee to continue to build upon the work of the SLEP Advisory Group.

Dr. Rief moved to approve the formation of the Joint City Council/School Board SLEP Subcommittee.

Mr. Harris seconded the motion.

The vote to approve the formation of the Joint City Council/School Board SLEP Subcommittee was unanimous, 6-0. The motion carried. Chair Alderton and Mr. Elnoubi did not vote as they were absent for the remainder of the meeting.

#### 31. Policy Revisions

Mr. Matt Smith, Policy Consultant, reviewed policy revisions as part of the Board's continuing Equity Audit of School Board Policies, changes to the Code of Virginia, and the requirement that policies are reviewed every 5 years.
