**TOPIC:** Policy Work Session #2: Revisions to E, G and L Policies/Regulations

#### **SUMMARY:**

As part of the Board's continuing effort to improve Board Meeting efficiency, policy revisions will be presented at four Work Sessions during SY 2019-20. At this second policy Work Session, the following policies and regulations have been revised from the policy manual classifications below:

**E Policies: Support Services** 

G Policies: Personnel

L Policies: Education Agency Relations

These revisions are primarily driven by changes to the Code of Virginia and Virginia Board of Education regulations. However, some have also been initiated by ACPS to either reflect current practice or the changing needs of the school division. Finally, some have been included to comply with the state of Virginia's five-year policy review requirement.
