SUMMARY: This memorandum informs the School Board on the academic calendar planning process for the 2022-2024 school years. The draft calendars will be presented to the community for feedback in April. After any edits, Board approval of the final calendars is scheduled for June 3, 2021.

BACKGROUND:

- 1. Calendar Committee membership. The Calendar Committee included representatives of teachers, parents, EAA (Employee Association of Alexandria) and PTAC (Parent-Teacher Advisory Council) members. The process was led by Human Resources members Sandra Hardeman, Director of Recruitment and Retention, and Sheril Waldron, Director of Compensation and Benefits; and Dr. Gerald R. Mann, Jr., Executive Director of Instructional Support.
- 2. Committee process. The committee considered multiple factors to develop the academic calendars including:
 - Maintaining the framework established in the 2021-2022 calendar
 - Using a pre-Labor Day start date, and using hours to exceed the state minimum of 990 hours.
 - Keeping the Wednesday before Thanksgiving as a holiday

RECOMMENDATION: The Superintendent recommends the School Board review the information and timeline for the 2022-2024 Academic Calendars.

IMPACT: A two-year calendar cycle improves long-range plans for school programs, facilities projects and operational services. Likewise, families will be able to better plan and schedule family activities.
