**SUMMARY**: ACPS has a standing MOU with APD that requires review and approval every two years. The MOU must be signed not later than November 2, 2020. The Office of Safety and Security Services will provide an update of the review and approval process for this MOU.

**BACKGROUND:** Five SROs are assigned to ACPS by the Alexandria Police Department on a daily basis during the school year. There are two SROs assigned to T.C. Williams High School, one SRO is assigned to the Minnie Howard Campus, and one SRO each is assigned to Francis C. Hammond and George Washington Middle Schools.

Virginia code 22.1-280.2:3 requires the School Board in each school division in which the local law-enforcement agency employs school resource officers to enter into a memorandum of understanding (MOU) with such local law-enforcement agency that sets forth the powers and

duties of such school resource officers.

For the 2020-2022 review process, ACPS and APD formed a joint-committee to review the past and future MOU. This review process included a public hearing, community feedback survey and the Board work session on October 15. The briefing will inform the Board of this process. Board guidance will be incorporated into the new MOU and presented to the School Board for a final review at a late October date.

## **RECOMMENDATION:**

The Superintendent recommends that the School Board review the attached information for the work session.

**IMPACT:** The Alexandria City Public Schools and Alexandria Police Department develop a partnership that supports a safe and secure school and campus environment for students, staff, families and all others.
