APPOINTMENT AND TERM OF THE SUPERINTENDENT

The Alexandria City School Board (Board) appoints the division Superintendent from the list of eligible candidates certified by the Virginia Board of Education and determines the term of employment. The Superintendent's term expires on June 30 of the year stated in their contract. The Superintendent serves an initial term of not less than two years nor more than four years. At the expiration of the initial term, the Superintendent is eligible to hold office for a subsequent term specified by the Board, not to exceed four years.

Except as provided below, if the Board fails to appoint a division Superintendent within 180 days of a vacancy, the Virginia Board of Education will appoint a Superintendent for the Division.

If the Board has not appointed a Superintendent within 120 days of a vacancy, it will submit a written report to the State Superintendent of Public Instruction demonstrating its timely efforts to make an appointment and containing a status report with a timeline for making the appointment prior to the 180-day deadline. On request, the Board will be granted up to an additional 180 days within which to appoint a Superintendent.

If the Board does not appoint a Superintendent within 180 days of a vacancy, or request additional time within which to make an appointment, it will immediately notify the Virginia Board of Education, in writing, of its failure to make an appointment. If there has been no extension, within 30 days of the 180th day after the vacancy occurs, the Board will submit, in writing, its preferred candidate(s), not to exceed three, for the position. The Virginia Board of Education may consider these candidates and other eligible individuals. The Virginia Board of Education may authorize the State Superintendent of Public Instruction to conduct the search for a division Superintendent.

If the Virginia Board of Education appoints a division Superintendent, the contract for the Superintendent will be negotiated by the Board.
