### **Data Collection and Reconciliation**

Incident Reporting

- Mandatory notifications sent by School Administrators post-incident
- In line with *SB Policy CLA*
- Incident reports do not always equate to a crime being committed
- Reconciled and logged by SSS once received

Call for Service Report Form (Police Assistance)

- Form completed by School Administrators when police assistance/support occurs
- In line with *July 1, 2023 SLEP MOU.*
- Reconciled and logged by SSS once received












### **Incident Reports by School Type, Q1 and Q2**










### APD Calls for Service by Month, Q1 and Q2










### APD Calls for Service by School Type, Q1 and Q2





#### High School Arrests/Referrals (8)

- Black Male (Non-Hispanic or Latino) 5
- Black Female (Non-Hispanic or Latino) 3

#### **ACPS Student Enrollment Demographics:**

•Asian: 6.6% •Black: 24.0%

•Hispanic: 37.6%

•White: 27.2%

•Native Hawaiian/Pacific Islander: 0.3%

•Native American: 0.1%

•Multi-racial: 4.2%









# Data Comparison by School Type and Semester


#### **Incident Report Comparison**
