TOPIC: Updated Quarter 2 Discipline Data

On April 12th, the School Board was presented with an update on the implementation of Restorative Practices and Positive Behavior Intervention and Supports, known as PBIS. The discipline data for quarter two was reviewed as a part of the presentation. The following chart was prepared by the Department of Accountability in response to a question about the suspension data being listed by as total suspensions per school which did not represent if a student was suspended more than one time. The updated information identifies the total number of suspensions at a school, how many students received those suspensions, and the number of suspension per student.
