SUMMARY:

As a result of the ACPS School Board's commitment and in alignment with the Virginia Literacy Act, Alexandria City Public Schools (ACPS) is focused on students' literacy achievement.

DETAILS:

This presentation updates the School Board on the actions currently underway to improve ACPS literacy achievement. With these efforts, ACPS will be well-positioned to realize the goals and requirements of the Virginia Literacy Act as it is enacted in SY 24–25.

BACKGROUND:

ACPS has been working to continuously improve its literacy instruction in light of the latest reading research. The work of ACPS' teacher leaders to innovate with new resources and practices has positioned ACPS to enter the 2024–2025 school year with VDOE-approved high-quality instructional materials already in place.

Enactment of the Virginia Literacy Act when it takes effect in Fall 2024 will entail a number of

requirements, including:

- Developing a division-wide literacy plan
- Ensuring all Kindergarten–Grade 5 teachers have and use evidence-based literacy resources for the entire literacy block
- Staffing at least one reading specialist for every 550 students in Kindergarten–Grade 3
- Providing professional development in evidence-based literacy practices to teachers, reading specialists, and principals
- Developing, implementing, and monitoring individualized reading plans for students falling below benchmarks on literacy screeners in Grades K–3.

ACPS leaders are working to manage legislation requirements in ways that will support teachers with growing into increasingly skilled use of evidence-based literacy resources and practices.

RECOMMENDATION:

The Superintendent recommends that the School Board review the information about ACPS' Literacy Instruction.
