SUMMARY:

The School Board has spent the past several weeks reviewing and deliberating the FY 2024 - 2033 Capital Improvement Program (CIP) Budget. At this meeting, the School Board is scheduled to adopt the CIP for consideration by City Council.

BACKGROUND:

In preparation for the FY 2024-2033 CIP, the School Board discussed and voted on budget priorities to drive the CIP formulation process. The School Board held joint work sessions with City Council on October 12 and 18, 2022, to discuss joint facilities planning and ACPS's proposed plan for the CIP. Work sessions were held on November 14 on the FY 2024 Budget and on November 28 on FY 2025-2033 Budget and enrollment, capacity and utilization. School Board Add/Deletes for the FY 2024-2033 CIP Budget were discussed during the December 7th and December 13th work sessions.

RECOMMENDATION:

The Superintendent recommends that the School Board adopt the FY2024 – FY2033 Capital Improvement Program Budget.

IMPACT:

The capital budget will support ACPS's needs for additional capacity, facilities upgrades, as well as transportation, technology and textbook modernizations.
