Internet content filter

noun

- 1. A technology that filters out unwanted categories of content while using the internet
- 2. Required for school divisions by federal laws (Children's Online Privacy Protection Rule and Children's Internet Protection Act)





What does Securly:// do?


- Filters internet content on chromebooks at school and home
- Provides parents a portal for monitoring online activity outside of school
- Detects cyberbullying, self-harm and potential violence
- Alerts schools and administrators of flagged content
- Provides 24/7 monitoring support for schools







- Ability to monitor online activity outside of school
- Provides options to configure access and control
- Sends weekly email reports
- Aligns with ACPS Digital Citizenship Plan








• 30 days of activity

- Can be filtered to show each child individually
- Fosters conversation between parent/child about learning and digital citizenship
- Shows parents sites accessed/blocked
- Shows activity on the school-owned device when the student is away from school







Detection of Cyberbullying, Self-harm and Potential Violence

- Targets keyword searches, gmail, Google docs and social media
- Provides real-time reports to school and division administrators

- Provides 24/7 monitoring support for schools
- Focuses attention on items that need immediate intervention
- Uses a threat assessment matrix to determine the risk and method of communication to schools
- Monitored by trained staff with backgrounds in psychology, sociology, criminology and experience with children



24 Alert Risk Assessment

	Clarifying Risk	Analyst Action
Low Risk	Activity flagged	Analyst should not take action at this time. If additional information comes through, re-assess and take into account this previous report.
	No direct threat present	
Moderate Risk	Student exhibiting clear distress	Analyst should notify, via email, the emergency contacts as indicated by the district. Email should indicate that the threat does not appear to be serious, but we are notifying the district to make them aware.
	Threat present	
	Threat is vague and indirect but may be repeated or shared with multiple people	
	Information about threat or threat itself is implausible or lacks detail	
	Threat lacks realism or is repeated with variations. E.g. "I'm gonna set off a nuclear bomb every Monday!"	
	Content of threat suggests threatener is unlikely to carry it out	
Increased Risk	Threat present	Analyst should notify, via email, the emergency contacts designated by the school. Email should indicate the threat appears to be serious, but not imminent.
	Threat is vague, but direct, or specific but indirect (vague/specific in terms of plans, direct or indirect in terms of target)	
	Repeated or shared multiple ways (e.g. email, text, FB)	
	Threat likely to be repeated with consistency (may try to convince listener they are serious)	
	Information about threat or threat itself is consistent, plausible or includes specific detail of a plan (time, place, etc.) but NOT set within the next 24 hours; often with steps already taken. e.g. 'I read about how to build bombs online. I've ordered some stuff that I need, but it won't be here for awhile. I should be ready when the school has that award assembly next month."	
	Content of threat suggests threatener may carry it out, but not within the next 24 hours	
Extreme Risk	Threat made or present	Analyst should notify, via SMS or phone, the emergency contacts designated by the school. Based on the urgency of timing, if there is no response, every effort should be made to notify law enforcement.
	Threat is concrete (specific and direct)	
	Repeated or shared multiple ways (e.g. email, text, FB)	
	Information about threat or threat itself is consistent, plausible or includes specific detail of a plan (time, place, etc.) set within the next 24 hours; often with steps already taken. E.g. "Don't go to the assembly tomorrow. I've hidden enough bombs in the auditorium to teach everyone a lesson about messing with me."	
	Threat may be repeated with consistency	
	Content of threat suggests threatener will carry it	

out (reference to weapons, means, target) within

the next 24 hours
