23. Middle School Athletics and Activities

Mr. James Parker, Executive Director of Athletics & Student Activities reported on the recommendation to begin middle school athletics and competitive student activity programs at Francis C. Hammond Middle School, Patrick Henry K-8 School, Jefferson-Houston Middle School, and George Washington Middle School. He also noted the introduction of forensics, scholastic bowl and debate to the middle school program to spark interest in these high school competitive programs.

24. The High School Project Recommendations

Mr. Alexander Duncan, Executive Principal at ACHS, reported on the continued work regarding educational programming of the The High School Project (THSP) in collaboration with The Learner-Centered Collaborative as consultants. There have been working groups meeting and recommendations moved forward to the Superintendent and Executive Leadership Cabinet for approval. The approval of these recommendations will shape further planning and support communication and engagement efforts with stakeholders about THSP.

25. Safety and Security Update

Dr. Alicia Hart, Chief Operating Officer, updated the Board on school safety data for Q3 and Q4 from the 2022-2023 school year. Collection and reconciliation of school safety data is a requirement of both school board policy and our School Law Enforcement Partnership Memorandum of Understanding (MOU). The MOU details the requirement to collect, review and reconcile specific data related to incidents on school campus grounds. It also requires ACPS to provide a summary of the quarterly meetings that occur with APD in regards to the SRO program. The most recent SRO/MOU Quarterly Meeting occurred on August 29, 2023.

26. Policy Revisions

Mr. Matt Smith, Policy Services Consultant presented on proposed revisions of several policies and regulations. Summaries of the revision, including links to code changes where appropriate, are presented in the memo. Red-line changes and comments are included in the draft policies. These policies have been reviewed for code alignment and VSBA model policy alignment, audited for equity, edited by a team of staff members, and reviewed by the SLT and the Board Policy Subcommittee.

These policies will return for adoption at a future board meeting.
