SUMMARY

The Enhanced Continuity of Learning Plan 5.0: Reimagining Schools was presented to the School Board on Thursday, October 15, 2020. Based on our commitment to providing regular communication to the School Board and Alexandria community, we have prepared this hybrid reopening presentation to focus on the following areas: Phased Re-Entry Process + Timeline; SEAL Support Mondays; April 2021 Vaccination Poll; Staff Transitioning Back to In-Person; PreK-12 Lunch Logistics; Summer Learning Program - Staffing Update; August School Opening - Staffing Update; Summer Learning + Fall Opening 2021: Learning Choice Form; ACPS Virtual Virginia Roadmap + Overview; and Fall Space Needs + Air Purifiers Update.

RECOMMENDATION

The Superintendent recommends the School Board review the updates pertaining to the reopening of schools related to specific school operations.

IMPACT

ACPS will implement a plan contingent upon community transmission metrics, staffing, and building capacity to ensure that all students and staff are healthy, safe, and engaged during the reopening of our school buildings while following required health and sanitation procedures from the *Alexandria Health Department (AHD)*, the *Centers for Disease Control and Prevention (CDC)*, and the *Virginia Department of Health (VDH)*. This plan also ensures that all students receive personalized academic support and interventions to address any learning losses resulting from school building closings.
