

- 2. Staff Recruitment and Retention (March 2024 May 2025)
  - Strategic Plan Revision Process (June 2024 May 2025)
- 3. English Learner Program (June 2025 August 2026)
- 4. Connected High School Network (September 2026 November 2027)
  - Develop next five-year evaluation calendar (Nov. 2027 March. 2028)
