## **Homebound Teachers**

Homebound teachers <u>mayshall</u> be employed on a <u>full-time basis or a part-time</u>, hourly basis. They <u>are shall be-selected from the active file of applicants in the Department of Human Resources or from the approved —substitute teacher list and <u>must meet the licensure certification requirement of the Virginia Board of Education (VBOE) shall hold a valid teaching certificate.</u></u>

## **Part-Time Teachers**

An employee working less than 180 days or less than six (6) hours per day or who is restricted to temporary or interim employment is considered part-time. Part-time teachers must shall meet the licensure certification requirement of the VBOEVirginia State Board of Education.

## Summer School Teachers
