#### V. Old Business and Action Items

- Updates on community partners and organizations excel sheet shared with group created by Ursula and Kristin
- Updates on secondary PE class sizes ACPS has started a review that will be implemented in FY26 to alleviate larger class sizes and combine smaller classes specifically in PE and world languages
- Update on FLE curriculum FLE Advisory Committee is being presented drafts of 6th, 7th, and 8th grade curriculums tomorrow to review and provide feedback
  - 9th and 10th grade drafts are in process and hopefully can be reviewed by the end of Feb.
  - Overall, these will be presented to SHAB in early spring
- Health Dept came to schools and did a mandated vaccination clinic and it extremely helped vaccinate ACPS students in need
  - Health Dept. is hoping to do another round this spring
  - Teen Wellness Center and Health Dept. is also is discussing about how to help and support getting students vaccinated
  - Robin shared concerns around HPV vaccinations and how not all students may be getting these
  - Question: Do we have data specifically around students with or without HPV vaccine?
  - ACPS has signed an MOU with the Health Dept. to share vaccination data so they can look deeply at areas of the community with specific needs and interventions
  - Vaccination/Immunization Information System that all providers are required to participate in where they must dump into the state database
  - VDH is working on a product where school districts can share vaccination data which will greatly help with students transferring
  - Deborah: How can we get a pediatrician to talk with families about vaccinations at well vistis?
    - Robin: That is happening thankfully at checkups.
  - Kristin: Does the Teen Wellness Center require that with sports' physicals?



- TWC can print off an official record to attach to the form and offer to students in need
- Noted the new Alexandria Health Department is challenging to find and access in the new location - additional signage would be helpful

- Next step, is to reach out to <u>Taneika Taylor Tukan</u> about the activity and current status of these community partners.
- Identify gaps in the status of community resources
- Bring awareness to families and ACPS staff about community partners
- Debra: Asked Brooke Curran what SHAB could do to help partners feel supported and desiring partnerships in the long-term.
  - Appreciated her recognition letter from ACPS for being a great community partner. A word of thanks goes a long way.
- Tammy mentioned in the past a community partner breakfast that ACPS held annually.
  - Believe iNova might have been a big supporter
- Kristin: Can Debra ask Tanieka Taylor Tukan about ways ACPS can recognize community partners?
- Amanda: Cost, especially food, is often a challenge. Creative ways could be brainstormed.
- Brooke: Adding a personal note is much appreciated as well.
- Kimberly: Asks that ACPS finds ways to support. Plan Z suggestion Fairfax County did a fair and each organization had a booth and it made a huge difference in collaboration and appreciation.
- Amanda: Student participation makes an impact in thanking partners as well.
