

STUDENT USE OF PERSONAL MOBILE DEVICES

Alexandria City Public Schools (ACPS) acknowledges that wireless connected personal mobile devices such as cell phones, personal tablets, and smart watches (personal mobile devices) are part of our student's daily lives and are increasingly important as an instructional tool in their educational program. ACPS also acknowledges that mobile devices can also be used in ways that adversely impact the safety and security of our schools. In order to ensure the appropriate balance across this range of priorities, ACPS has established this regulation as a supplement to Policy IIBEA - Responsible Computer System Use with the purpose of promoting a safe school environment that is conducive to learning and is welcoming to all.

ACPS has established communications procedures to ensure students and families are able to be in contact during the school day for events such as a student needing to attend an appointment, an planned early dismissal, or simply a forgotten lunch. Students and families should reach out to the school's front office to assist with the contact.

This regulation will be effective at the start of the 2023-24 school year.

Unless otherwise directed by an administrator, students in all grades are permitted to have and use personal mobile devices on school buses and school grounds before and after school.

During the day, student personal mobile devices must be silenced or turned off and stored in a secure location. Schools will provide secure locations to store the cell phones. Options include but are not limited to secured classroom spaces such as lockable drawers, purses, lockers, or backpacks. Smart watches may be worn, however, the communications features must remain off during the school day. Secondary students have limited exceptions as described below. Administrators may make exceptions as appropriate which will be communicated through various channels.

Administrators, teachers, coaches, and other staff performing supervision activities have the autonomy to determine if personal mobile devices are needed for instructional or other valid purposes and may permit use when appropriate.

Elementary Students (Grades Kindergarten-fifth grade)

Personal mobile devices must be silenced (or turned off) and put away during the school day. Personal mobile devices can be stored in a school-identified secure location.. Smart watches may be worn, however communications features should remain off during the school day. Students are prohibited from using cell phones, tablets, and mobile devices, including ACPS issued devices, in restrooms and locker rooms in an effort to protect the privacy rights of others.

41 **Middle School Students (grades six to eight, including sixth and eighth graders attending**
 42 **Jefferson-Houston preK-8 IB School and Patrick Henry K-8 School)**

43 Personal mobile devices must be silenced (or turned off) during the school day. Personal mobile
 44 devices can be stored in a school-identified secure location. Smart watches may be worn, however
 45 communications features should remain off during the school day. Students are prohibited from
 46 using cell phones, tablets and mobile devices, including ACPS issued devices, in restrooms and
 47 locker rooms in an effort to protect the privacy rights of others.

49 **High School Students (Grades nine to postgraduate, all Alexandria City High School**
 50 **Campuses)**

51 Personal mobile devices must be silenced (or turned off) during the school day with the exception
 52 of during lunch and in between classes/periods. Personal mobile devices can be stored in a school-
 53 identified secure location. Smart watches may be worn, however, communications features should
 54 remain off during the school day. Students are prohibited from using cell phones, tablets and
 55 mobile devices, including ACPS issued devices, in restrooms and locker rooms in an effort to
 56 protect the privacy rights of others.

58 **Medical Exceptions**

59 Families of students with medical conditions such as diabetes, seizures, hearing aids, etc. that use
 60 a personal mobile device as part of the physician prescribed treatment should contact the school's
 61 principal for an exception to this regulation.

62

63 **Digital Citizenship, Common Sense Media Supports**

64 The use of cell phones within schools is a privilege provided to our students. We encourage
 65 families to review appropriate use of cell phones with their students; to this end, as part of ACPS's
 66 Digital Citizenship curriculum, provides Common Sense Media resources as a support for families
 67 and students. The supports and lessons focus on behavior, awareness, and reflection skills that
 68 help students to make good decisions and apply to any digital device..

- 72 ● Privacy and Security

81 **Responses to Inappropriate Personal Mobile Device Use**

82 Students are expected to comply with this policy while on school grounds, in school buses, and
83 when participating in any school-related activity. Students using personal mobile devices in any
84 manner that disrupts the educational environment, from within or from outside the classroom, or
85 violates the rights of others, including, but not limited to:

- 86 ● using the device in violation of Policy JFC - ACPS Student Code of Conduct
- 87 ● using the device in violation of Regulation JFC-R2 - ACPS Honor Code
- 88 ● using the device in violation of Policy JFCC - Student Conduct on School Buses and at
89 Bus Stops;
- 90 ● harassing or bullying (to include cyber-bullying) of students or staff;
- 91 ● photographing (to include indecent photos) or video recording (to include indecent videos
92 and recording of physical fights and altercations), or;
- 93 ● using social media channels to post inappropriate photos or videos of students and/or staff;
- 94 ● using their device for unlawful purposes

95
96 will be subject to disciplinary action in accordance with ACPS policy including JGD/JGE - Student
97 Suspension/Expulsion. In accordance with ACPS Policy, including CLA - Reporting Acts of
98 Violence and Substance Abuse, inappropriate use may, if applicable, be reported to the Alexandria
99 Police Department.

101 **Responsibility**
102 Students are solely responsible for their personal mobile phones, ACPS accept no responsibility
103 for student personal mobile devices.
