FY2025 CIP Budget Summary

- → Includes \$67M for the construction of George Mason ES
- → \$5.1 Million included for the renovation and completion of the 5th and 6th Floor of 1701 N. Beauregard.
- → \$2M for the construction of the bleachers at Parker-Gray Stadium (ACHS King Street)
- → Multiple repairs and renovations of varying systems at schools identified in the FCA's in alignment with Budget Priority:

 Systemic Alignment
- → Curriculum & Instruction Material and Technology funds included (approx. \$4M)

Adjustments to FY25

- → FY25 is a decrease of \$18.1M from last year's approved FY25 CIP Budget
- George Mason was reduced \$20M
- Several non-capacity projects were deferred from FY25 to accommodate the City's guidance
 - George Washington Fields (\$3M)
 - Naomi L. Brooks Kitchen (\$750,000)
 - Charles Barrett Kitchen (\$1.5M)

Playground Assessments













The Facility Engineering Associates Site Condition Assessment evaluated playgrounds by using:

- → US Consumer Product Safety Commission Public Playground Safety Handbook
- → National Recreation and Park Association: Playground Safety C
- → ADA Standards for Accessible Design
- → ACPS Educational Specifications

Playgrounds at all schools were evaluated and assessed. Playgrounds at schools were evaluated separately if not spatially connected. (ex. John Adams-Large and John Adams-Small).

*Final report was received November 10th. Updates to CIP Book will be provided in Work Session #2 on November 27th.













- → Assessment found that no playgrounds need to be immediately closed due to safety concerns. Safety items identified on Pg. 14 of the assessment will be addressed expeditiously through maintenance work orders.
- → ACPS Office of Safety and Security Services oversees the playground safety inspection process each summer. Repairs are then made according to inspection reports.













Playgrounds were assessed and summarized by their Current Replacement Value (CR), Deferred Maintenance Value (DM), and Condition Index (DM/CR).

Current Replacement Value: Cost for replacing the playground "as is"

→ ACPS Portfolio CRV: \$10,957,832

Deferred Maintenance Value: Cost of maintenance and repairs that have not been performed

→ ACPS Portfolio DM: \$1,353,287













Condition Index: Industry-recognized measure of the relative condition of assets across a portfolio, calculated as the ratio of deferred maintenance to current replacement value (DM/CRV). The smaller the condition index, the better the condition of the portfolio of assets.

- John Adams (Large): \$405,000 in FY25
- Mount Vernon (Small): \$200,000 in FY26
- Lyles-Crouch: \$200,000 in FY27

Capital maintenance items identified by the assessment in FY 25-34 are included for all schools.

 Including these items will maintain playgrounds until the budget and budget guidance allow for new playgrounds to be included.

CRV was provided for all schools. New non-critical/safety projects for schools were <u>not</u> included in this CIP due to City guidance.

 Design and Construction would have been included for new playgrounds designed to the educational specifications for schools with highest Condition Indexes.











- → Educational Specifications standards were also evaluated. This standard measured for accessibility and educational adequacy.
- → The assessment found that the total need to address Educational Specifications items is \$2,503,700. 70% of the items identified were accessibility-related items.
- → All new playgrounds will be designed to the ACPS Educational Specifications where budget and site development allows (Douglas MacArthur, George Mason, Cora Kelly, 1703 N. Beauregard)
