Redistricting Criteria

- <u>Instructional Capacity</u>: Number of students assigned to a school takes into account the number of classrooms and resource rooms needed for art, music, labs, ELL, special education and Talented and Gifted.
- <u>Student Safety</u>: Promote safe walk zones-routes to school.
- **<u>Transportation</u>**: Minimize need for bus transportation or travel time.
- **<u>Enrollment Capacity</u>**: Student enrollment provides room for future growth.
- <u>**Class Size</u>**: Adhere to and accommodate ACPS policy on class size requirements at different grade levels.</u>
- **<u>Distribution of special programs</u>**: Consider balance and access to Divisionwide programs (special education; pre-k).
- **<u>Previous Rezoning</u>**: Minimize need for more than one boundary change in the elementary life of a student.
- **<u>Program Continuity</u>**: Minimize school assignment change for students who have spent the majority of their elementary experience in the school.
- **Sensible and Fair Boundary Lines**: Consider the proximity to the school, and to extent possible, look for natural points to define boundaries.
- **<u>Diversity</u>**: Consider rich diversity of school division.



What are Division level programs?

Recommended programs:

- Dual-language
 - Currently located at John Adams and Mount Vernon
- Modified Calendar
 - Currently located at Samuel Tucker
- K-8
 - Currently located at Jefferson-Houston



What criteria were used to identify programs?

- Superintendent recommended program to the School Board
- Instructional program that impacts day-to-day instruction and/or schedule
 - Instruction delivered in Spanish as a part of the core subjects
 - Pacing of instruction
 - Continuity of program, differences in course offering
- Significant financial commitment



What is an exemplary program?

- Enhances instructional core subjects through differentiated strategies and resources
- Increases interest in the school program
- Selected at the school level
- Supported by ACPS, the PTA and/or third party grant funding which is annually reviewed

¹ Each grade level removes the students and their associated siblings accounted for in the grandfathering analysis of the higher grade level. For example, if a future 5th grade student has a future 3rd grade sibling, the future 3rd grade sibling is ONLY counted in the future 5th grade analysis and not in the future 3rd grade analysis. ²Number is based on a calculation using 2016-2017 projections.

What would the impact be if all grades were exempted from redistricting?

- Only 2017-2018 rising Ks with no siblings will phase in
- Capacity reassignments (previously MOEs) will continue
- Building utilization will increase
- Increased need for transportation
- Relocatables will be necessary
- School schedules will be impacted (ex: start and end times for lunch)
- Access to core spaces for students and staff will be compromised
- Potential need to increase class sizes
