25. 2024-2025 Secondary Program of Studies

Ms. Carmen Sanders, Executive Director of Instructional Support, gave an update on changes to the Program of Studies (POS) since first presented to the Board on October 21, 2023. The Program of Studies includes information about diploma types and division practices that support student learning. The POS also includes a comprehensive list of courses available to meet

graduation requirements, provides opportunities to explore a wide range of disciplines, and meets diverse student needs and interests.

In addition, the Board requests flexibility to manage resources and set policies at the local level that are in the best interest of the local community.

New Business and Reports to the Board

27. Social Emotional and Academic Learning (SEAL) Update

Ms. Kennetra Wood, Executive Director of Equity and Alternative Programs, presented an update on how ACPS is prioritizing the academic, social and emotional well-being of students and staff through the Social Emotional and Academic Learning (SEAL) program. The program incorporates the Collaborative for Academic, Social, and Emotional Learning (CASEL) framework which identifies five competencies that students should learn to demonstrate. The presentation also updated the School Board on the current implementation, monitoring and assessment of students acquiring the five CASEL competencies. Ms. Wood also shared how students are demonstrating their application of these competencies in classrooms and schools as a result of the SEAL program.

28. Release of the Superintendent's Proposed FY 2025-2034 Capital Improvement Program (CIP) Budget

Dr. Melanie Kay-Wyatt presented Capital Improvement Program Budget (CIP) of \$313,957,900 for the next 10 years. The fiscal guidance presented by the City recommended that schools maintain the total amount of capital funding included in the approved CIP for years 2-10 (\$316 million), but distributed across the FY 2025 – FY 2034 planning window.

29. Policy Revisions

Mr. Matt Smith, Policy Consultant, proposed revisions of several policies and regulations. The policies have been reviewed for code alignment and VSBA model policy alignment, were audited for equity, and reviewed by staff, leadership and the Policy Review Committee.
