

I received the response from ACPS and said family could change on DL or Hybrid after filling out the form. But I saw this on the FAQ page today: 'When families fill out the form are they held to their choice? If they choose hybrid, but then decide it is not safe, can they pull back to virtual (or vice versa)?

We want to encourage families to select one option and stick with it. We need this information to be consistent so that we plan effectively for the reopening of schools. Families are encouraged to make the choice based on metrics, willingness and ability to adhere to all guidelines. That said, we cannot predict tomorrow. We hope that everyone will make the best decision possible and stick with it but we do understand things could change for a family and will work with families as needed.

If we opt to do 100% virtual on the form, will there be an opportunity to change that later in the spring if we feel it is safe to return?

Those situations can be addressed on a case-by-case basis. 'It looks like it is really hard to make the change based on the above responses. I am a bit confused right now, can you/ACPS clarify? Thanks.

Please know that we are committed to working with families throughout this transition process knowing that circumstances may change and families may need to adjust their choice in the future. However, we ask families to provide a decision based on the information provided with the intent to begin your choice at the designated time for your child's grade level. We are relying on our partnership with families to make this transition work as smoothly and efficiently as feasible during these unprecedented times.'
