FIRE DRILLS

Each school in Alexandria City Public Schools (ACPS) holds at least two fire drills during the first twenty school days of the school year, in order that students and staff members may be prepared in case of a fire emergency. Each school handles notifications to parents when a drill will take place. If a parent has specific questions or concerns that cannot be resolved by the school and Specialized Instruction, they will bring in Safety & Security to assist.

Commented [3]: How are they made exempt? Are Pre-K and K parents notified of the date/time so they can keep their student home?

Commented [5R3]: Same, I'm wondering the rationale and how this is implemented

Commented [6R3]: This "exemption" phrase comes directly from the Code of Virginia 22.1-137.2. In Safety & Security Services guidance to our schools, the rationale is that it takes this age group longer to train. We always encourage all staff to practice when they can, without students, in order to maintain their proficiency. "Secure the Building" can be done with all grades, maybe we should clarify or reword. It is the "active threat" evacuation and evacuation to a safe place that is more of a challenge (with students of this age). This is only for active threat "lockdown" type drills. Fire Drills are still required.
