SUMMARY:

A broad cross-section of policies and regulations have been revised for SY 2020-2021 to incorporate COVID-19 public health protocols and distance learning-related guidance. They are compiled from the policy manual classifications below:

- **E Policies: Support Services**
- G Policies: Personnel
- I Policies: Instructional Program
- J Policies: Students
- K Policies: School- Community Relations

Although primarily driven by changes related to the global pandemic, some revisions may also reflect current ACPS practice or amendments to the Code of Virginia and Virginia Board of Education regulations.

The chart below outlines proposed changes to the following policies and regulations. **Orange** text reflects revisions/feedback received since the August 27, 2020 Work Session.

BACKGROUND:

On Friday, March 13, 2020, ACPS closed all schools due to the Coronavirus/COVID-19 pandemic in order to promote physical distancing and the safety and wellness of school staff, students, and their families. On the same day, Governor Northam ordered all Virginia schools closed for a period of two weeks. On March 23, 2020 the <u>Governor ordered all Virginia schools to remain</u> <u>closed</u> for the remainder of the 2019-2020 school year.

On June 9, 2020, Governor Northam "<u>announced a phased reopening</u> of K-12 schools, which gradually permits in-person instruction to resume while prioritizing the health and safety of students and staff. In order to minimize the disparate impacts closures have had on students," the reopening plan (revised July 9, 2020), "prioritizes the needs of students who have been most impacted by school building closures, and for whom in-person instruction is most beneficial." (VDOE, July 6, 2020)

At the conclusion of a robust engagement and planning process that incorporated thought partners and cross-functional planning teams, ACPS submitted its reopening plan, <u>Virtual Plus+</u>, to the Virginia Department of Education on August 14, 2020. Building upon the resulting recommendations, an ACPS core team collaborated over multiple weeks to review and refine the proposed amendments to impacted policies. These proposals continue to be shared with school and administrative staff, as well as key stakeholders to obtain additional insight.

RECOMMENDATION:

The Superintendent recommends that the School Board approve the policy revisions reflecting COVID-19 public health protocols and distance learning guidance during the 2020-2021 school year.

IMPACT:

By revising the attached policies for SY 2020-2021, ACPS will:

- Adhere to mitigation strategies that minimize the spread of COVID-19 established by the Centers for Disease Control and Prevention (CDC), the Virginia Department of Health (VDH) and the Alexandria Health Department (AHD);
- Align with VDOE's return to school plan implementing Virginia's phased reopening of K-12 schools during the COVID-19 pandemic;
- Prioritize safety precautions for the benefit of ACPS students and staff;
- Comply with Superintendent's Memo #188-20, *Tracking Attendance for the 2020-2021 School Year*;
- Recognize the ongoing impact of providing new instruction to students remotely and to address learning lost due to the spring 2020 school closures (<u>Executive Order 53, (March</u> <u>2020</u>); and
- Ensure maximum flexibility and benefit for ACPS students while maintaining opportunities for mastery of content standards.
