BACKGROUND:

On Friday, March 13, 2020, ACPS closed all schools due to the Coronavirus/COVID-19 pandemic in order to promote physical distancing and the safety and wellness of school staff, students, and their families. On the same day, Governor Northam ordered all Virginia schools closed for a period of two weeks. On March 23, 2020 the <u>Governor ordered all Virginia schools to remain closed</u> for the remainder of the 2019-2020 school year.

On June 9, 2020, Governor Northam <u>announced a phased reopening</u> of K-12 schools, which gradually permitted in-person instruction to resume while prioritizing the health and safety of students and staff.

As of August 12, 2021, a <u>Public Health Order</u> requires all individuals aged two and older to wear masks when indoors at public and private K-12 schools, regardless of vaccination status, with limited exceptions. The Order also applies to Pre-K if the program is at a K-12 school. Masks must be worn on school buses per <u>a federal order</u>.

The Public Health Order reinforces the current state law (<u>Senate Bill 1303</u>) that requires Virginia schools to offer in-person instruction for the 2021-22 school year, and to the maximum extent possible, to use prevention strategies outlined by the CDC. <u>CDC's recommended strategies</u> currently include masking of all staff, students, and visitors while indoors.

RECOMMENDATION:

The Superintendent recommends that the School Board approve the policy and regulatory revisions related to COVID-19 for the 2021-2022 school year.

IMPACT:

By revising the attached policies for SY 2021-2022, ACPS will:

- Adhere to mitigation strategies that minimize the spread of COVID-19 established by the Centers for Disease Control and Prevention (CDC), the Virginia Department of Health (VDH) and the Alexandria Health Department (AHD);
- Prioritize safety precautions for the benefit of ACPS students, staff and visitors;

- Recognize the ongoing impact of the COVID-19 pandemic on students and address learning loss due to the spring 2020 school closures (<u>Executive Order 53, (March 2020)</u>; and
- Ensure maximum flexibility and benefit for ACPS students while maintaining opportunities for mastery of content standards.
