Chair's Update:

Dr. D. Ohlandt: Tonight's meeting will focus on one of our three prongs of our scope of work – AAS services at the middle and high school level.

- Chair will look into ordering the book for committee members titled: <u>Educating Gifted Students</u> in Middle School, Third Edition.
- Chair also shared an update on a process underway by an ACPS school board subcommittee to examine the five current advisory committees to better understand their legal boundaries and what ACPS wants the advisory committees to do, among other things. What the subcommittee is finding is that all six advisory committees operate very differently from each other. What we need to explore is where we are aligned with the other advisory committees and where we should not be aligned. Chair encouraged members to review our bylaws which are available on ACPS website.

Ashley Simpson Baird, School Board Member:

We have liaison roles on the school board. She has been serving on the Governance Advisory Committee to examine our structures. One of the recommendations we will make in the near future is a more structured process for the board to accept recommendations from the advisory committee, so committee members know their time is appreciated and valued.

Budget process will begin in early January. The Superintendent will present her budget on January 4th and then the board will begin work sessions. A public hearing will be January 18th. This will be the first budget cycle where we can consider funding implications for the new AAS local plan.

Since Willie Bailey has resigned from the board and was the liason to AASAC, Board Member Baird offered to answer any questions we have until a new liaison is selected.
