SEX OFFENDER NOTIFICATION REGULATION

I. WHAT IS A PROCEDURE IF A VISITOR IS FLAGGED AS A SEX OFFENDER?

~~1.~~ If a sex offender is flagged by ~~KeepnTrack~~, the ACPS Visitor Management System, the school principal and front office staff, relevant administrators and the Office of Safety and Security Services receive an alert. ~~visitor will receive the following message on the kiosk screen:~~

~~2.~~ “~~Visitor may not sign in at this time. Please check with the main office.~~”

If the visitor reports to the front desk, please ask the visitor to wait for an administrator or designated “Alert Person*.”

~~3.~~2. The identified Alert Person will receive an email and/or text message stating:

“An ACPS Visitor Management System ~~KeepnTrack~~ registered sex offender check has found a match.”

The email/text will also provide a list of possible matches. The Alert Person will ~~need to~~ review the list of names and pictures of possible matches provided via the email/text to determine if the visitor is identifiable as an individual restricted as a registered sex offender.

3. If the visitor is not identifiable as one of the possible matches, the Alert Person will apologize for the inconvenience and allow the visitor entry.

4. If there is a possible match, please proceed accordingly:

- Ask ~~him or her~~ the visitor to wait a moment.

- Contact appropriate authority –

- Elementary Schools - Call the Alexandria Police Department at (703) 746-4444 and wait for an Officer to arrive.

- Middle / High Schools - Notify onsite School Resource Officer (SRO) or proceed as above if one is not readily available.

- Police Officer/School Resource Officer will take the appropriate action.

II. DEFINITION

“Alert Person” —~~An Alert Person~~ is the administrator or other designated school staff who has been selected to handle school security issues relevant to the ACPS Visitor Management System. ~~KeepnTrack~~.
