The Web Content Accessibility Guidelines (WCAG) are part of a series of web accessibility guidelines published by the Web Accessibility Initiative (WAI) of the World Wide Web Consortium (W3C), the main international standards organization for the Internet. They are a set of guidelines that specify how to make content accessible, primarily for people with disabilities—but also for all user agents, including highly limited devices, such as mobile phones.

 For the main ACPS website and any official ACPS web presence that is maintained by ACPS, including content provided through third party vendors, ACPS is committed to compliance with the provisions of the Americans with Disabilities Act (ADA), and Sections 504 and 508, as applicable, so that students, parents and members of the public with disabilities are able to independently acquire the same information, engage in the same interactions, and enjoy the same benefits and services within the same time frame as those without disabilities, with substantially equivalent ease of use. Any non-conforming webpages will be corrected in a timely manner. ACPS will work with third party vendors to resolve accessibility issues as they may arise on their sites.

Website Accessibility Concerns, Complaints and Grievances

A student, parent or member of the public who wishes to submit a complaint or grievance regarding a violation of the Americans with Disabilities Act (ADA), or Section 504 and 508, as applicable, related to the accessibility of any official ACPS web presence that is maintained by, or offered through ACPS or third party vendors, may file a complaint.

Filing a Complaint
