SUMMARY:

On November 11, 2021, the Superintendent will present the recommended Capital Improvement Program Budget for FY 2023-2032. The Superintendent has prepared a CIP budget that addresses the school division's need for construction, and the expansion of capital assets to ensure the provision of learning environments that support high performing schools and accommodates capacity needs for our school population. The adoption of the Capital Improvement Program is an annual commitment to a series of projects with estimated costs based on current knowledge, market conditions, and projects.
