## **IKFD-R - Credit by Exam Regulations**

- Title change to better reflect the content of the policy
- VSBA model policy alignment
- Organized the options for earning credits into a waiver section per the code. This gives the division the ability to add other waivers if desired.
- Struck language from the regulation which was time limited

• Increased the number of credits that can be awarded for world languages from 3 to 4. This gives the students who are proficient in multiple languages the ability to earn two credits in each of two languages thereby satisfying graduation requirements.

#### JFG - Search and Seizure

- Struck language around law enforcement officers ability to search that wasn't in the model policy
- Added a section on strip searches
- Clarified that school rules apply to parking lots and vehicles are subject to search
- Removed references to 4th amendment rights

- Reworded to improve clarity
