

## STUDENT TRANSPORTATION SERVICES

The Alexandria City School Board provides transportation for students in grades K-8 living beyond a one-mile walking distance from the school they attend. The Board provides transportation in grades 9-12 for students living beyond a one-and-one-half mile [walking distance radius](#) from the school they attend. ACPS provides transportation to any student eligible for qualifying services or accommodations, as defined in Regulation EEA-R/EEAB-R. [In accordance with Policy JC/JCD](#), ACPS does not provide transportation for students who have received an administrative transfer outside of their attendance zone.

All conditions regarding the transportation of students stipulated by the Code of Virginia, regulations of the Virginia Board of Education, and policies and regulations of the School Board shall be met.

Students may be suspended from school transportation services for violations of the Student Code of Conduct or when the student endangers the health, safety, or welfare of other riders. In such cases the parent or guardian shall be responsible for transporting the student to and from school for the duration of the suspension from transportation services.
