## 24. Adoption of the FY 2025-2034 Capital Improvement Program (CIP) Budget

Vice Chair Booz made the following motion:

"Madam Chair, I move that the Alexandria City School Board approve the FY 2025–2034 Capital Improvement Program Budget in the total amount of \$379,555,400, with \$107,657,700 in FY 2025.

The Superintendent is granted the authority to make the necessary minor changes to comply with the intent of the School Board."

Ms. Ignacio seconded the motion. The vote to adopt the FY 2025-2034 Capital Improvement Program (CIP) Budget was unanimous, 7-0. The motion carried. Ms. Greene voted orally.

### 25. School Year 2024-2026 Academic Calendars

The proposed 2024-2025 and 2025-2026 Academic Calendars were reviewed at the November 30, 2023 School Board Meeting and were presented for adoption at this meeting. The calendars prioritized student attendance and staff retention. The calendar committee made recommendations to the superintendent based on regulations approved by the Board on June 15, 2023.

Vice Chair Booz moved to adopt the 2024-2025 and 2025-2026 Academic Calendars.

Mr. Harris seconded the motion.

The vote to adopt the academic calendars for 2024-2025 and 2025-2026 was unanimous, 7-0. The motion carried. Ms. Greene voted orally.

### 26. Elementary and Secondary School Emergency Relief (ESSER) Funds Update

Chief Financial Officer, Dominic B. Turner, presented on the Elementary and Secondary School Emergency Relief (ESSER) Funds Update. The purpose of the American Rescue Plan (ARP) Act Elementary and Secondary School Emergency Relief (ESSER III) Fund is to help safely reopen and sustain the safe operation of schools and address the impacts of COVID-19 on the nation's students by addressing students' academic, social, emotional, and mental health needs. ACPS has been awarded \$34.8 million in ESSER III funds. Each school division must make publicly available updates on its plan.

### New Business and Reports to the Board

### 27. Update on New ACPS Logo

Chief of School and Community Relations, Julia Burgos, presented two versions of a potential new ACPS Logo. The Office of Communications will be launching a new community feedback form on the logo options in the December 8, 2023 "Express" and "Insider." The form will be open from Friday, December 8 to December 18, 2023 at 11:59 p.m. Following this feedback

period, the superintendent will share the final recommendation to the School Board at a January meeting for acceptance.

## 28. Minnie Howard Building Update

Senior Capital Program Manager, Arthur Carpenter-Holmes, presented on The High School Project: Construction Update which focused on the construction of the new Minnie Howard building. Construction has been ongoing since the spring of 2022 and is on track to be completed this spring for occupancy in August 2024.

### 29. Family and Community Engagement (FACE) Center Update

Assistant Director of Family Engagement, Krishna Leyva, and Family Engagement Coordinator, Avanda Williams-White, presented the Family and Community Engagement (FACE) Center update on the progress of the multi-year roll-out of school-based family engagement blueprints across the division. The family engagement blueprint leverages the power of families and family-school partnerships to influence student outcomes, including attendance, social-emotional well-being, grades and behavior.

### **30. Policy Revisions**

Mr. Matt Smith, Policy Consultant, reviewed the proposed policy revisions. Candidate policies for revision are drawn from code changes, changes in the VSBA model policies, the code requirement that policies are reviewed every 5 years, and policies and regulations that have been identified by the Board and/or staff for review.
