This will not increase confidence in the safety and efficacy of COVID vaccines or the integrity of the FDA. Indeed, three New England Journal of Medicine authors (Michelle M. Mello, J.D., Ph.D., Ross D. Silverman, J.D., M.P.H., and Saad B. Omer, M.B., B.S., M.P.H., Ph.D.), who conditionally support vaccine mandates, acknowledge:

[E]xcept for influenza vaccination of health care workers, mandates have not been widely used for adults.... The fact that a vaccine has received Food and Drug Administration (FDA) approval...is an insufficient basis on which to conclude that it should be required. FDA approval...may be based on very limited evidence and consciously or unconsciously influenced by the intense pressure to speed countermeasures to market.

Ensuring Uptake of Vaccines against SARS-CoV-2

Critical questions

Is the ACPS SB prepared to be sued for violating personal conscience rights under the First Amendment or federal or state Religious Freedom laws? Are they willing to accept liability for possible adverse reactions?

All current FDA authorized COVID vaccines (as of 8/22/21) are linked to abortion. Will Dr. Fauci's "guidance" and FDA approval of the COVID vaccines be used by lawmakers to compel Americans who believe in the sanctity of each human life to take vaccines tested on or derived in part from preborn children killed by abortion?

Distinguished Catholic University Law Professor, Robert Destro, who served on the U. S. Civil Rights Commission and as Assistant Secretary of State for Democracy, Human Rights, and Labor, has warned that "Guidance" from the CDC does not have the force of law and cannot repeal existing civil and human rights protections in federal and state laws:

Employers who mandate vaccines without allowing for medical exemptions run the risk of violating the Americans with Disabilities Act, and both State and federal laws require accommodation of religious objections. But the real ticking time-bomb is civil liability for adverse effects. If businesses mandating vaccines think that CDC "Guidance" will protect them from liability for known adverse effects, they are delusional. [personal communication] Fauci and other vaccine promoters have had to claim that, contrary to published and reviewed studies, drugs like Hydroxychloroquine (HCQ) or Ivermectin could not safely and effectively

treat COVID because federal law states the FDA Commissioner may only issue an Emergency Use Authorization (EUA), "...when there are no adequate, approved, and available alternatives." However, Dr. Peter McCullough and at least 250 doctors treated between 10,000 and 15,000 patients a day using HCQ or Ivermectin and other drugs approved by the FDA for other purposes. Dr. McCullough believes their approach "could reduce hospitalization and death by 85%" if used widely across the US (sic).

Liberty Counsel has received many, many inquiries on the various COVID shot mandates and requests for sample exemption request letters. Faith-based exemption requests (as opposed to health, ingredients, philosophical, or other bases) remain the strongest basis for an individual exemption.

Most mandates are currently coming from employers and educational institutions. In the employment context, Title VII prohibits workplace discrimination on the basis of religion. The First Amendment applies to public employers and educational institutions. The current "Emergency Use Authorization" ("EUA") status of all of the COVID shots means that they cannot be mandated.

Many of our clients and constituents hold sincere pro-life religious beliefs that prohibit them from participating in or benefiting from an abortion. Some believe that they may not benefit in any way from an abortion, no matter how remote in time that abortion occurred. Others have prayed and asked God whether they should get the COVID shot and have received a clear word from the Lord in their spirit that they must not get the shot. Still others do not feel such a leading; but support the individual believer's "liberty of conscience," consistent with the principles outlined in 1 Corinthians 8. There are also those who have recovered from COVID due to healthy immune system God has given them, and are themselves protected from getting COVID due to natural immunity, and a reliance upon God's protection consistent with Psalm 91.

The Johnson & Johnson (Janssen Pharmaceuticals) COVID shot "did require the use of fetal cell cultures, specifically PER.C6, in order to produce and manufacture the vaccine." Multiple state department of health "FAQs" confirm that while mRNA vaccines by Pfizer-BioNTech and Moderna do not "contain" fetal cells, but clearly state that "[e]arly in development of mRNA vaccine technology, fetal cells were used for 'proof of concept' (to demonstrate how a cell could take up mRNA and produce the SARS-CoV-2 spike protein) or to characterize the SARS-CoV-2 spike protein." Thus, both Pfizer and Moderna used abortion-derived cell lines to "to **test the efficacy** of both vaccines." Therefore, claims that Pfizer and Moderna "do not require the use of any fetal cell cultures in order

to manufacture (produce) the vaccine" are in conflict with the statement that "such a cell line was used to test the efficacy of both vaccines." 4 "Testing the efficacy" is certainly a part of the research and development process.

In order for an employee or student to prevail under a claim for a religious exemption, whether based on pro-life or other religious beliefs, religious beliefs must be sincerely held, and the requested accommodation must be "reasonable," and not constitute an undue hardship on the employer or institution.

The manner in which the employer or institution continued its operations in 2020, prior to the availability of the COVID shots, establishes a baseline of treatment of employees or students that is not an "undue hardship." It will NEVER be an "undue hardship" for the entity to allow the employee or student to continue doing what was considered "safe and effective" or "mitigating" in the absence of the vaccine. However, such treatment may become discriminatory, if novel or additional restrictions or requirements are applied to the person who should otherwise be exempt. If the COVID shots work, those people who have received them are protected, and it is not an undue hardship for individuals who have religious objections to not receive such shots.

A pastor verification letter is beneficial to proving the sincerity of the belief, but is not legally required. It is nonetheless very helpful in substantiating a claim that one's belief is religious in nature, and that it is sincere. The following samples serve as a guide only. **DO NOT copy and paste them verbatim**. We encourage each individual to prayerfully consider what he or she believes, and why. Each individual should seek God's will through prayer, of whether he or she should comply with the COVID shot mandate directed toward them, or whether the Holy Spirit is leading, guiding, or moving their spirit to refuse the COVID shot.

If you have a sincere religious conviction against taking a COVID shot, you can put the following applicable sample text in your own words and submit as a religious accommodation request. Otherwise, it may be retained for your future personal use.

SAMPLE EMPLOYEE/STUDENT EXEMPTION LETTER:

I'm writing to request a medical and religious exemption from [COMPANY NAME's/COLLEGE NAME's] COVID shot directive. I have prayed about how to respond to the COVID shot directive, in light of my [medical issues], and in light of my pro-life and other religious beliefs. I believe my body belongs to God and is the temple of his Holy Spirit. 1 Cor 6:19-20. I believe that innocent life is sacred to God, from conception, to birth, to natural death. (Jeremiah 1:5). I believe God's promise that "if anyone lacks wisdom, let him ask of God, who gives to all liberally." I understand that the manufacturers of the COVID shots have used aborted fetal cell lines as part of their development or testing of vaccines. My faith prohibits me from participating in or benefiting from an abortion, no matter how remote in time that abortion occurred.

Jesus said the Holy Spirit will guide each person who repents of their sin and believes upon Him into all truth. As a believer in Jesus, the Holy Spirit lives in me. I have been a Christian for many years. I seek God's will for my life through prayer,

reading the Bible, and relying on the power of the Holy Spirit to help me to do God's will.

It is against my faith and my conscience to commit sin. Sin is anything that violates the will of God, as set forth in the Bible, and as impressed upon the heart of the believer by the Holy Spirit. In order to keep myself from sin, and receive God's direction in life, I pray and ask God for wisdom and direction daily. As part of my prayers, I have asked God for direction regarding the current COVID shot requirement. As I have prayed about what I should do, the Holy Spirit has moved on my heart and conscience that I must not accept the COVID shot. If I were to go against the moving of the Holy Spirit, I would be sinning and jeopardizing my relationship with God and violating my conscience.

I'm therefore asking for an exemption from the COVID shot directive so that my conscience can remain clear before God. Thank you for your consideration.

SAMPLE PASTOR VERIFICATION LETTER:

I understand that NAME has submitted a religious exemption request from the COVID vaccine directive. As his pastor, I can speak to the sincerity of his faith and his request. NAME told me that after the directive to accept the COVID vaccine came out, he started searching the Scriptures as to how he should respond, and if he should accept the shot.

NAME is a Christian, and believes the Bible to be the inspired, inerrant, living Word of God. When Jesus Christ went back to heaven after He was resurrected, He promised to send his Holy Spirit, who would guide us into all truth. Our church teaches that each believer in Christ receives the Holy Spirit, who directly leads the individual in his walk with God, as the believers seeks wisdom through prayer and Scripture reading. See the doctrine of the priesthood of the believer. Our church teaches that believers should follow their conscience, as informed by the written word of God, and the leading of his Holy Spirit. Our church teaches the Biblical sanctity of human life, and the Biblical interdiction against abortion as the shedding of innocent blood. Many Christians understand this interdiction to include ingesting or benefiting from products derived from or using aborted fetal cell lines.

NAME has told me that based on his review of Centers for Disease Control (CDC) guidance and position statements, and understanding of the issues, and much prayer that he might discern truth from error, and whether he should get the shot, the Holy Spirit is not allowing him to accept the COVID shot. He believes that if he were to do so, he would be sinning against our living God. Our church supports him as he follows the leading of the Holy Spirit and supports his request for a religious exemption.

Pastor NAME

Again, every person should prayerfully consider what God through the Holy Spirit is leading him or her to do, and should make an individual written request, using these samples as guides. **UNDER NO CIRCUMSTANCES** should the samples be copied and pasted.

Assuming that the samples accurately reflect your religious beliefs, you can model your response after them, or change as necessary to reflect your beliefs.

Ensuring Uptake of Vaccines against SARS-CoV-2

As Covid-19 continues to exact a heavy toll, development of a vaccine appears the most promising means of restoring normalcy to civil life. Perhaps no scientific breakthrough is more eagerly anticipated. But bringing a vaccine to market is only half the challenge; also critical is ensuring a high enough vaccination rate to achieve herd immunity. Concerningly, a recent poll found that only 49% of Americans planned to get vaccinated against SARS-CoV-2.¹

One option for increasing vaccine uptake is to require it. Mandatory vaccination has proven effective in ensuring high childhood immunization rates in many high-income countries. However, except for influenza vaccination of health care workers, mandates have not been widely used for adults.

Although a vaccine remains months to years away, developing a policy strategy to ensure uptake takes time. We offer a framework that states can apply now to help ensure uptake of the vaccine when it becomes available — including consideration of when a mandate might become appropriate. Our approach is guided by lessons from U.S. experiences with vaccines for the 1976 "swine flu," H1N1 influenza, smallpox, and human papillomavirus (HPV).

We believe that six substantive criteria should be met before a state imposes a SARS-CoV-2 vaccine mandate (see box). The first is the existence of evidence that Covid-19 is inadequately controlled in the state by other measures, such as testing, contact tracing, and isolation and quarantine — as indicated by sustained, troubling trends in new cases, hospitalizations, or deaths. Principles of public health law and ethics require that interventions that impinge on autonomy be reasonable and necessary; therefore, Covid-19 must present an ongoing threat. By the time a vaccine is available, more will be known about natural immunity in the population, the consequences of relaxing community mitigation measures, and the feasibility of scaling up test-and-trace strategies. There should be a reasonable indication as to whether further measures are needed.

Six Trigger Criteria for State Covid-19 Vaccination Mandates.

- Covid-19 is not adequately contained in the state.
- The Advisory Committee on Immunization Practices has recommended vaccination for the groups for which a mandate is being considered.

- The supply of vaccine is sufficient to cover the population groups for which a mandate is being considered.
- Available evidence about the safety and efficacy of the vaccine has been transparently communicated.
- The state has created infrastructure to provide access to vaccination without financial or logistic barriers, compensation to workers who have adverse effects from a required vaccine, and real-time surveillance of vaccine side effects.
- In a time-limited evaluation, voluntary uptake of the vaccine among high-priority groups has fallen short of the level required to prevent epidemic spread.

The second criterion is that the Advisory Committee on Immunization Practices (ACIP), after reviewing the safety and efficacy evidence, has recommended vaccination for the persons who would be covered by a mandate. Currently available evidence suggests that the elderly, health professionals working in high-risk situations or working with high-risk patients (e.g., nursing home residents and patients with severe respiratory symptoms), and persons with certain underlying medical conditions may be high-priority groups for the ACIP's consideration, along with other workers with frequent, close, on-the-job contacts and persons living in high-density settings such as prisons and dormitories. When a vaccine nears approval, the ACIP should review the updated evidence and develop recommendations. Only recommended groups should be considered for a vaccination mandate, though health officials can encourage voluntary uptake for others, using means such as public education campaigns and free vaccination.

The fact that a vaccine has received Food and Drug Administration (FDA) approval — whether under an Emergency Use Authorization (EUA) or ordinary review processes — is an insufficient basis on which to conclude that it should be required. FDA approval reflects a determination that clinical trial evidence shows that the benefits of a vaccine outweigh its risks. ACIP recommendations reflect broader considerations, including values and preferences of affected groups, implementation issues, and health economic analyses. Overweighting FDA decisions would be particularly problematic for SARS-CoV-2 vaccines because EUAs may be based on very limited evidence and consciously or unconsciously influenced by the intense pressure to speed countermeasures to market.²

The third criterion is that there is an adequate supply of vaccine to cover the groups for which a mandate is being considered. Initially, global demand for SARS-CoV-2 vaccines will outstrip supply, making the salient question not who must get them but who will be granted access to them. New York State's unsuccessful attempt to mandate H1N1 influenza vaccination for health care workers demonstrates that imposing requirements before adequate supply has been secured needlessly provokes controversy and alienates people who have already made sacrifices to fight an epidemic.³

The fourth criterion is that there has been transparent communication of the best available evidence about the vaccine's safety and efficacy. Particularly given the possibility that the evidence underlying FDA approval of SARS-CoV-2 vaccines may be more modest than usual, policymakers and the public will need to understand the limits of what is known. Public trust has already been compromised by federal officials' endorsement of hydroxychloroquine as a Covid-19 treatment without evidentiary support; the same must not occur for vaccines.

The fifth criterion is that the government has put in place certain support mechanisms for persons required to receive the vaccine. Lessons from past vaccination campaigns suggest that a generous compensation program for people who have serious vaccine side effects should be a centerpiece of these efforts. A federal compensation fund like the Smallpox Vaccine Injury Compensation Program is one attractive model, although identifying compensable injuries may be challenging with a novel vaccine. States will also have to create distribution systems to provide SARS-CoV-2 vaccine to high-priority groups with near-zero financial and logistic barriers — for example, bringing free vaccine to points of care, pharmacies, and work sites. It is equally critical to have a safety-assessment plan in place before vaccines are widely distributed to enable health officials to evaluate safety evidence in real time. States should work with health systems to ensure that reporting systems for vaccine-related adverse events are consistently used and specify a process for reconsidering mandate decisions as evidence evolves.

The last criterion is that vaccination mandates are imposed only after a time-limited trial of voluntary vaccine provision has proved unsuccessful. Principles of public health ethics support trying less burdensome policies before moving to more burdensome ones whenever possible. In this case, the costs of a failed voluntary scheme are sufficiently high that the attempt should be limited to a matter of weeks. States should implement a system for measuring vaccine uptake within each high-priority group against a set of coverage targets. Ensuring that the economic and logistic supports described above are in place will maximize the chances for success.

If the proposed trigger criteria were met, what might a vaccination mandate look like? Because the constitutional power to protect public health rests primarily with states, each state will need to adopt its own legislation. Proposed legislation should be supported by attestations from the state health officer, the ACIP, or another expert committee that all trigger criteria have been met. Targeted SARS-CoV-2 vaccination mandate policies may also be appropriate in certain federal contexts, including high-risk groups in active-duty military environments, Veterans Affairs facilities, federal prisons, and immigration detention centers.

Although state vaccination mandates are usually tied to school and day care entry, that approach is not appropriate for SARS-CoV-2 because children won't be a high-priority group. In addition, state mandates should not be structured as compulsory vaccination (absolute requirements); instead, noncompliance should incur a penalty. Nevertheless, because of the infectiousness and dangerousness of the virus, relatively substantive penalties could be justified, including employment suspension or stay-at-home orders for persons in designated high-priority groups who refuse vaccination. Neither fines nor criminal penalties should be used, however; fines disadvantage the poor, and criminal penalties invite legal challenges on procedural due-process grounds. Both are bad public health policy for a Covid-19 vaccine because they may stoke distrust without improving uptake.

The need to build public trust requires that state officials implement vaccination policy through a transparent and inclusive process, working closely with stakeholder groups such as local health officers, health professional and hospital associations, representatives of high-risk population groups, and groups concerned about vaccine safety. States' experience with HPV vaccination mandates offers another process tip: vaccine manufacturers should stay on the sidelines. The HPV vaccine manufacturer's direct involvement in crafting and lobbying for mandate legislation

raised suspicion that profit rather than public health motives lay behind such proposals, undercutting support for vaccination even without a mandatory regime.⁵

As with social distancing orders, we can expect that the advent of SARS-CoV-2 vaccines will spark intense clashes of feeling about what people owe to one another in the fight against the pandemic. In contrast to earlier phases of the pandemic, though, we currently have some time on our side. Careful deliberation now about state vaccination policy can help ensure that we have a strategy when the breakthrough comes.
